 - a) **6/2009/0376 Holme Nurseries Ltd**, West Holme Farm, Mr Simon Goldsack, extension of opening hours to allow for evening functions
 - Use permitted 14 days per annum to demonstrate viability of any business and that no nuisance is experienced/ caused to surrounding properties . The Councillors also questioned the position regarding licensing which is not addressed. Concern was expressed at a large number of vehicles arriving and leaving the property, during the hours of darkness.
 - b) **6/2009/0380 Hyde Pit**, Gallows Hill, East Stoke, Hansons, New Site Access Puddletown Road
 - No objections
 - c) **6/2009/0396 West Holme Farmhouse**, Mr D Bennett, erect double car port with store.
 - The Parish Council consider this to be too big and too high within the AONB. Concern also expressed at the length of time the hedges will take to grow.

Cllr Quinn has requested a meeting with Tim Westwood (DCC Transportation Manager) and with Network Rail. This has been raised with the Chief Executive @ Purbeck District Council. Consultation commences September 2009

Cllr Lovell (DCC) expressed concern that the hedges are obscuring the 50mph signs and need to be cut back.
A two tier system for Purbeck Schools has been agreed in principle, additional consultations to be held for Wool & Swanage.

Cllr Quinn (PDC), on 12th August will be completing a ward tour with Steve McKenzie, Chief Executive PDC, this to include the level crossing and Luckford Farm. Cllr Quinn will be raising the issue of accidents at the Holme Bridge turning with Tim Westwood.


