7. Planning Applications or Planning Information received

P/LBC/2023/00390 - Grapevine Cottage, **BH20 6AH**. Internal alterations to ground floor of existing 1960s extension to re-instate kitchen facilities and create home office.

The Parish Council has no comments or objections. The other planning application for this property will be discussed next month.

8. Update on Previous Applications or planning information

P/HOU/2022/06010 - Grapevine Cottage, BH20 6AH. Replace roof to former annexe with the addition of a glazed gable and dormer, create first floor accommodation within. Associated internal and external alterations to Listed cottage, alterations to landscaping. **Refused. Noted.**

10. Any Police issues to report or update on issues reported

There was an RTA on 9th January whereby a car crashed into a telegraph pole. BT have been working to resolve the connections for the past few weeks.

11. Village Hall

The closing date for the online survey was 1st February and so far 67 people have responded,

with a few paper versions still to arrive. The number of responses equates to approximately 35% of the population of East Stoke. The results of the survey are displayed in the appendix. It was discussed that to go forward, a business case needs to be written to demonstrate the affordability of the running costs. The research will be conducted by looking at villages of a similar size with halls for example Morden and Moreton. It was commented upon that the D'Urberville in Wool now has an income of £34K per annum. It was agreed that Cllr Quinn, Cllr Langley and Cllr Keith Evans will work together in compiling the business case. The developer has offered to do a presentation.

The SID is working well, although if you are driving below the speed limit already it doesn't thank you.

c) Other Issues

- The drain along the A352 to the east of Middlefield has been cleared. It was questioned whether there could be a spring located nearby but it was felt that it would be unlikely as the water has completely gone due to the dry weather. Work was carried out to alleviate the flooding on the A352 at Hethfelton and the water cleared overnight.
- According to the Local Government Association (LGA), councils in England and Wales are calling for a ban on HGV drivers using faulty satnavs. Incidents like HGVs getting stuck under bridges, crashing and causing delays have mainly been down to satnavs directing HGVs like they're a standard vehicle. It was suggested that a letter should be written to the MP asking if he can support this ban.


16. Items for information or next agenda

 in her twenties and is one of the youngest Parish Chairs in the County.




Do you feel there is a need for a village hall in East Stoke?
