#### 1 Election of Parish Council Chairman for 2017/18

## 12. Police Issues to report or update on issues reported.

Ros Ham does a sterling job as Home Watch co-ordinator for this Parish. They would like to extend the network, therefore if anyone knows of people who would like to undertake this role in other areas then please let them know. The scheme is not only about crime, but also to look out for vulnerable residents. Recently there have been suspicious vehicles and poaches in the local area. If people see anyone acting in a strange manor they should call the Police. There is now an online reporting tool that is being used in conjunction with the 101 service. The page can be found on the Dorset Police website under the title "Do it Online". Cllr Cady asked if motorbikes were spotted using the bridleway which would be the best way to report it and they recommended to call 101 first, but if the phone line is busy to report it online.

# **10. Reports from County and District Councillors**

## a) County

The new County Councillor for North West Purbeck which includes East Stoke is County Cllr Wharf and South Purbeck is County Cllr Brooks. The new Leader of the County Council is set to be Rebecca Knox and Peter Wharf will be appointed as Deputy Leader.

# b) District

- i) There are no updates regarding the Local Government Review due to purdah. Christchurch Council is threatening a judicial review and a referendum. Also, due to the purdah period there is nothing happening with setting up forums as part of the Purbeck Local Plan Review.
- ii) There will be a cycling event on Sunday 14<sup>th</sup> May which will start at the D'Urberville Centre in Wool and the course will be around Coombe Keynes and Lulworth. Outriders will be present, but the roads will not be closed.
