# RUINS OF OLD ST. MARY'S CHURCH

We are making some progress concerning the preservation of our crumbling Heritage site, i.e. the ruins of the old St. Mary's Church and graveyard. A representative of English Heritage visited and they are keen to stop further deterioration. A professor from Bournemouth University's Archaeology Dept. Dr. Ian Hewett has also visited the site and agrees that it is of great interest, as is the field in which it is situated. A mature student has now been delegated to photograph and map the area as a project and it is hoped that a colleague of Dr. Hewett will look at the site as being of environmental interest also. Thus some sort of management plan can be drawn up between English Heritage and the University to protect the site on an ongoing basis. This will increase the change of getting some funding for fencing the area. We approached the church in America, St. Brendan's Episcopal Church, Franklin, Pennsylvania, who now own the East Stoke font (previously in the old and more recent St. Mary's) to tell them of our project. Not only did they send us pictures of the font in its new home but gave a generous gift of \$300 to help with the fencing.

## **FLOODING**

The council has been investigating the ongoing flooding problems that primarily have affected the area between Binnegar Lane and Middlefield Cottages. Whilst concerns have been raised that these problems are attributable to the Hines Pit landfill site, our investigations indicate that this does not appear to be the case. It is a little more complex in that there are a number of contributory factors:

- The water table in this area is very high following a number of very wet winters.
- Old natural springs may have been activated.
- The drains and ditches in Binnegar Lane and the A352 are often blocked and not being cleared regularly enough.
- The field drains behind Middlefield Cottages are not working efficiently enough to cope with the surface water run off.

Our representations to the local authorities have led to short term actions being taken to clear the drains on the A352 more often, repair of broken drainage pipes and the installation of a new gully by the old garage to drain the surface water from the A352.

We are continuing to lobby the local authorities on your behalf to get improvements to the land drainage system. It is hoped that this will deal with the water run off from the fields more effectively and prevent problems with the adjoining properties. We will report on progress in the next newsletter.
