# 1 Public Participation Time 7:00-7:15pm

Cllr Shakesby confirmed that he did attend the meeting referred to in minute 129/13, the minutes of 6<sup>th</sup> November to be amended to reflect this.

Concern expressed regarding accidents outside Holmebridge House, complaints have been made to Police, some work has been carried out with regard to road markings but these have become obliterated by tank track marks. Between 6:00am and 8:00 am vehicles are considered to be driven at high speeds and are not obeying the no overtaking signs. This has been previously discussed with Richard Bastow, unfortunately unable to place double white lines on a straight road.

Tank movements, concern expressed that small tanks with trailers are ignoring the stated speed limits. Additionally tanks and tank carriers are crossing the railway at Holmebridge without telephoning for permission. Where small convoys cross at Stoke Crossing they back up onto the main road creating a hazard. Clerk to contact Bovington for clarification and advice.

- **10 Freedom of Information** –New Model Publication Scheme, the Cllrs considered the information provided and noted that it was not an option to implement. It was resolved that the scheme be adopted and the Clerk to prepare paperwork for the next meeting
- 11 Data Protection Act-Registration of Parish Council as a Data Controller, Councillors considered whether the Council should be registered and requested Clerk to obtain further information.

## 12 Highways Issues

Cllr Whitmarsh reported on recent Highways Seminar, re-organisation is planned, (R Bastow leaving) poor communications with people on the ground. Senior Management are aware, Cllr Whitmarsh and Cllr Lovell to liaise on reporting

Lengths man Scheme, suggestion that this could cost each Parish £2000, effectively 50% of precept

Parish Maintenance Unit, due in January, Cllr Whitmarsh to liaise with Blair Turner, tree on junction to be referred to Les Evans

#### 13 Registration of Footpaths,

Cllrs are not aware of any paths used, that are not recorded on the register.

Current liaison officer, lan Howlett is looking to stand down, when a replacement is identified. Cllrs to establish if anyone is willing to take over this role, if not, an advertisement to be placed on the notice boards.

Footpath SE14/10 appears to be no longer used, to be checked by Cllr Child.

#### 14 East Stoke Crossing

Meeting has been reschedules for 2009; the crossing is being opened more speedily. Requirement to establish what happened at the enquiry. Comment made that all trains are slower, may be due to work at Bindon Abbey.
