#### 1 Presentation From Representatives of Monkey World 6:30pm

Presentation of four applications due to be submitted to PDC

6/2010/0078 Buggy Store for 40 mobility scooters/ electric wheelchairs, need to be charged and dry for use by visitors.

6/2010/0077 Replace existing Malagasy enclosure, to replace existing fence 2.4m with 2.7m with overhang, no change to current footprint.

6/20100076 For the welfare of the primates, two groups of orang-utans cannot mix, therefore looking to erect a dividing fence 4 m high, in line with exterior fence). Fences over 2m require PP 6/2010/0075 Replace Capuchin enclosure building and improved capuchin enclosure – to replace an existing outdoor enclosure building (to be accessed from he existing Capuchin building) and an improved outdoor enclosure area. No tree to be affected, the land is not currently used. There are no intentions for a breeding programme, space to be increased from approx. 80sq m to 800sqm. Pathway to be widened to accommodate mobility scooters

#### 2 Public Participation Time 7:00-7:15pm

Members of the public raised numerous objections to Planning Application 6/2010/051, it was noted that the navigation lights were not part of the original approval. It was questioned as to what additional data may be collected in the next 12m that has not been previously available. No information was available on bird kill statistics, property values are being affected. Is mast safe and secure for a further 12 months. Local residents could not see where the extension application was advertised near to the mast, nor had they received written notification.

Concerns were expressed at the speed and volume of traffic on Bindon and Holme Lane. It was question why a C Class road has a limit of 60mph. Majority of problems appear to stem from the level crossing at Wool. There are minimal accidents reported but debris is seen on the roads. Letter to be sent to DCC requesting consideration be given to reducing the speed limit. Is there a minimum width for a 60mph speed limit. Verges are being destroyed. Could the 30mph limit be extended? Could a weight restriction be implemented, satellite navigation systems are directly unsuitable size vehicles on to narrow lanes. A suggestion was made to liaise with Arne Parish Council. Spring newsletter to include requests for notification of minor incidents/ near misses

Comment was also made that vehicles are increasing their speed immediately after passing the static speed camera. Police to liaise with Rob Camp.

It was noted that the broken finger post previously reported was still unrepaired, Clerk to follow up.

# 8 East Stoke Crossing-Update

Consultation delayed due to project delays, due to commence April 2010. Aim is for re-signalling work to be completed by October 2012 with Commissioning in December 20102. Holmebridge crossing, new furniture but no other changes, Rushton Crossing, refurbish gates and align pedestrian crossing. East Stoke, looking to close. This raises many issues, ROW, Emergency services, boundary changes. Cllr Quinn is seeking further information and further details are available from the Clerk. David Emmerson has agreed to brief Parish Council.

# 9 County & District Councillors Reports

Cllr Barry Quinn PDC advised of the DCC property review which is currently being undertaken in Purbeck. Following last month's request for location for battery recycling location it has been identified that all sellers of batteries are required to provide recycling opportunities. WDDC provide battery bags and collect with recycling.

Cllr M Lovell, DCC Consultation over Schools continues, DCC currently busy with budgets, concern that a saving of £8m is required.

**10 Helthfelton Woods**, PCSO Hann advised that the Forestry Commission are gathering evidence for an eviction and are looking to resolve the current situation as soon as possible. Currently many of the caravans are empty. Forestry Commission are unable to take pre-emptive action over the land.
