5 Members of the public were present

1 Public Participation Time 7:00-7:15pm

- a. Concern expressed regarding trailer parked in Church Lane. Police and Highways Agency are aware, it is understood that an Enforcement Notice is to be issued. Cllr Barnes offered for trailer to be moved to her property. PCSO Hann offered to contact the owner to advise him of this offer
- b. Tanks, 3 low loaders used the unmanned crossing on 18th December am on route to Lulworth, they returned fully loaded and were not seen to have telephoned for permission to cross.
- c. White lines have been obliterated by tanks, T Junction lines have not been replaced. Reported to PMU and Cllr Lovell.
- d. Speeding, no enforcement of speed regulations along road for 3 years, 2 major accidents, cars and bikes are exceeding speed limits excessively. Need enforcement opposite junction not close to camera. Approach Rod Camp, for SID, will they cover other than 30mph zones. Data produced is easily accessible, if data indicates that registered speeds are well above average they will attend more frequently. Camera safety partnership will visit after SID data is analysed.
- e. Parishioners to be encourage to write to Camera Safety Partnership, sterile response are issued but they are taken note of. If there are barriers preventing CSP attending may be able to request extra assistance from traffic Police. Refer via Stuart Hann and look at local use of speed laser.
- f. Post cards provided for delivery with next magazine.
- g. PCSO Stuart Hann visits 3rd Tuesday in Community Service Van, have been moving around the village, Middlefield Cottages identified as most central and safe location
- h. Incidents reported where a person has been seen trying to entice dogs, comment made that this is a national problem targeting dogs with value or bitches for breeding.
- i. Binnegar, quad and motor bikes being used in the quarries including very young children. Previously warnings have been issued. Now occurring most Saturdays and Sundays, as not with owner's permission the Police do have the authority to act.
